


HAWKE'S BAY

GENERAL ENGLISH

The General English programme is a good choice if students want to improve their English communication and also if they want to prepare for further certificate, diploma or degree-level study. The programme also provides a good basis for improving their language level prior to taking IELTS, or Speech New Zealand examinations.

STYLE OF TEACHING

Our motto 'Live the Language' means that we encourage active participation from our students. Tutors are skilled in the communicative approach to language learning, using the outside world to help in the classroom.

A collaborative style of teaching and learning is encouraged through team building, getting to know each other (teachers and classmates) and sharing experiences. The classroom is a place where our students are free to ask questions and to challenge themselves.

ASSESSMENT TYPES AND FREQUENCY

Each teaching block is four weeks. During the course you will have regular assessments. For the first three weeks, assessments are to monitor your progress. At the end of each fourth week you will have an assessment to show how much improvement you have made during the total 4 weeks.

CLASSES

The average number of students is up to 16. You will have access to language and computer laboratories to support your learning. You will have regular one to one tutorials with your teacher to help you reach your goal.

NEW ZEALAND CERTIFICATE IN ENGLISH LANGUAGE (NZCEL)

Gain entry to one of our mainstream academic programmes without sitting IELTS!

New Zealand Certificates in English Language (NZCEL) qualifications are nationally recognised qualifications for learners of English who are intending to study an approved academic programme in New Zealand, or continue their academic studies elsewhere. The entry level will be determined by the Placement Test before students arrive at EIT.

Students can choose to follow NZCEL Academic or NZCEL General programmes. The NZCEL Academic allows the students to move to mainstream academic programmes. The NZCEL General is for students who want a certificate to show their attendance on a nationally recognised programme.

NZCEL LEVEL 1

For elementary students - IELTS Level 2-2.5 or equivalent

NZCEL LEVEL 2

For pre-intermediate students - IELTS Level 3 - 3.5 or equivalent

NZCEL LEVEL 3

For lower intermediate students - IELTS Level 4 - 4.5 or equivalent

NZCEL LEVEL 4

For upper intermediate students - IELTS Level 5 - 5.5 or equivalent

NZCEL LEVEL 5

For advanced students - IELTS Level 6 or equivalent

Students studying at NZCEL Level 3 and above will also have knowledge and skills to cope with an academic curriculum in an English speaking tertiary level institution.

STYLE OF TEACHING AND ASSESSMENT

The style of teaching and assessment is the same as for the General English programme.

IELTS PREPARATION

IELTS preparation classes are designed to improve your test-taking strategies, to familiarise you with the IELTS test format and to improve your English level prior to taking the test.

The classes are offered as an extension option within our full-time programme or can be taken by residents as a part-time 8 hours per week course.

Out-of-class study is strongly encouraged to include practice in Tasks One and Two of the writing module as well as reading and listening tests that students are able to borrow to use at home.

CUSTOMISED ENGLISH LANGUAGE TOURS

ACCOMMODATION



The Student Village at EIT Napier has been rated as 4 star plus accommodation by NZ Qualmark since 2008 and has beed awarded a Silver Environment Award

HOMESTAY

We strongly recommend you apply for homestay accommodation. Our homestay families provide a warm and welcoming environment with your own room and meals provided. It gives you the opportunity to assimilate into the New Zealand way of life by becoming part of a local family.

All of our homestay families are carefully selected and supervised. They have been vetted by police and inspected by EIT staff. In your acceptance pack will be a homestay request form. It is important that you be as open and honest as possible about your personality and lifestyle so we can match you to a suitable family. EIT endeavours to make the best match possible based on this information; however some requests may not be met due to homestay family availability at the time.

PLEASE NOTE THAT:

- The homestay fee does not cover personal items such as phone calls, toiletries, excessive Internet use, bus fares or entrance fees to any activities with your homestay family.
- Students who go on holiday during their homestay period pay \$95 for the first full week and \$45 per week for the second week and consecutive weeks. These must be full weeks.
- Students should commit to the first four weeks in the homestay family. EIT does not change homestay placements in the first month as it takes some time for students to settle into their new lifestyle, and for the family and student to adjust to each other.
- Students should give one week's notice to EIT to vacate a homestay placement.
- All payments for continuing homestay should be made through EIT.
- A \$150 fee will be charged to request a change of homestay family.
- The weekly homestay fee for students requiring halal food will be \$220 (Napier).

To apply for EIT accommodation, please indicate on your Application Form which accommodation you are interested in. We will send you an application package for the accommodation option of your choice. Please note the accommodation fee payment is required before accommodation can be secured.

STUDENT VILLAGE

The Student Village (SV) is a self-catering complex of 12 villas housing six students in each, with on-site managers providing 24-hour support for resident students.

The SV is located on campus next to the Sports Centre and bus stop. Both New Zealand and international students live together and the villas are also mixed gender. The SV is a multicultural communal environment that is better suited to more independent students. It is a great environment to meet other students, study and relax together and regular events are organised by the managers.

Students will be required to pay a one-off \$200 deposit and will sign a contract with the SV for a minimum of one semester (20 weeks). Where the programme of study is shorter than one semester, the student may sign a contract for the length of their enrolled programme (based on room availability).

Rooms fill up fast and EIT can only normally secure rooms for students who have paid and returned their SV contract forms before arrival at EIT.

PRIVATE ACCOMMODATION

Students are welcome to arrange their own private accommodation. Rent ranges from \$100 to \$200 per week depending on the location and if utilities are included.

ESSENTIALINFORMATION

IMMIGRATION

New Zealand Immigration Service requires a student to have NZ\$15,000 in their bank account to cover living costs for one year of study, or \$1500 per month, plus a return ticket to their home country.

Full details of visa requirements, advice on employment rights in New Zealand while studying, and reporting requirements are available through the New Zealand Immigration Service, and can be viewed on their website at www.immigration.govt.nz

MEDICAL AND TRAVEL INSURANCE

International students must have appropriate and current medical and travel insurance from the time they leave home until they return from New Zealand to their home county. EIT's preferred provider is Uni-Care insurance. There is no insurance application paperwork for you to complete as insurance fees are included in the invoice along with your tuition fees. It's easy, and you can have the confidence that you are covered from the day you leave home for New Zealand.

Most international students are not entitled to publicly funded health services while in New Zealand. If you receive medical treatment during your visit, you may be liable to pay the full costs of that treatment. Full details on entitlements to publicly-funded health services are available through the Ministry of Health, and can be viewed on their website at www.moh.govt.nz

For more information on Uni-Care insurance please visit their website on **www.uni-care.org** - Please contact the International Centre as soon as possible should you decide to organise your own insurance as all insurance policies must meet a minimum standard of care and cover for Immigration New Zealand and Code of Practice requirements.

ACCIDENT INSURANCE

The Accident Compensation Corporation provides accident insurance for all New Zealand citizens, residents and temporary visitors to New Zealand, but you may still be liable for all other medical and related costs. Further information can be viewed on the ACC website at www.acc.co.nz



CODE OF PRACTICE

EIT has agreed to observe and be bound by The Code of Practice for the Pastoral Care of International Students administered by the New Zealand Qualifications Authority. The code is a document which provides a framework for service delivery by educational providers and their agents to international students. The purpose of the Code is to ensure high quality pastoral care is delivered to all international students studying at New Zealand institutes.

The Code sets out the minimum standards of advice and care that is expected of educational providers with respect to international students. The code applies to pastoral care and provision of information only, and not to academic standards.

- English language tuition fees are reviewed each year.




